What does this course cover?

This course emphasizes the role of the medication aide as a valuable member of any health care team. This course focuses on legal mandates for medications and proper



administration in various routes utilizing the "rights" and three safety checks of medication administration. This course introduces basic terminology related to medication administration and drug reference. The course will focus on medication actions, safe dosage ranges, adverse reactions, and impact on body systems. Students will apply classroom learning in the laboratory setting promoting safe medication administration.

Who should attend?

- » Minnesota law governs the qualifications required to work as a medication aide in a licensed nursing home which include:
 - Individuals 18 years of age or older and have completed an approved Minnesota State
 Nursing Assistant Training Program
- » A person who challenges the Minnesota nursing assistant exam or transfers in from another state, for example, would not be eligible. It is the responsibility of the facility to document completion of an approved nursing assistant training program.

- » It is recommended a nursing assistant has worked for 6 months or more before taking the course
